Motion carried unanimously on a roll call vote.

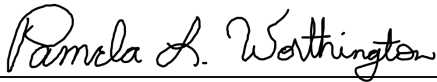
3. **BOARD OF COMMISSIONERS – APPOINTMENT OF BOARD OF COMMISSIONERS' CHIEF OF STAFF**
